#### At a Disaster Recovery Center, you can . . .

- > Register for FEMA assistance by using phone banks at the center
- > Check the status of your application
- > Meet with a FEMA applicant assistant representative
- > Obtain information about state agencies and voluntary organizations
- Discuss the U.S. Small Business Administration's (SBA) low-interest loans for homeowners, renters and businesses
- > Obtain information on how to reduce future damage

# Who May Be Eligible For Disaster Assistance?

- ✓ U.S. Citizens
- ✓ Qualified Aliens
- ✓ Non-citizen Nationals

The Qualified Alien category generally includes individuals who are Lawful Permanent Residents holding "Green Cards."

A "Green Card" holder is someone who has been granted authorization to live and work in the United States on a permanent basis.

TO APPLY FOR DISASTER ASSISTANCE Call 800-621-3362 (TTY 800-462-7585) Apply online www.disasterassistance.gov Qualified Aliens also may include those who have legal resident status because of:

- Asylum
- Refugee status
- Parole into the U.S. for at least one year
- Withholding of deportation
- Immigration from Cuba or Haiti
- Severe forms of human trafficking, including persons with "T" and "U" visas.

To be eligible for state and federal disaster assistance, only one member of a household needs to be a:

- U.S. citizen,
- · Qualified Alien, or a
- Non-citizen national.

Disaster assistance may be available to a household if a parent or guardian applies on behalf of a minor child who is a U.S. citizen or a Qualified Alien.

A household of individuals with varying citizenship status may be eligible.

- Applicants should consult an immigration expert concerning whether or not their immigration status falls within the Qualified Alien category.
- Residents who do not qualify for state and federal aid may be referred to voluntary agencies for assistance.

**Direct Deposit:** Disaster assistance funds can be sent directly to your bank account. Please provide your bank account type, account number and bank routing number.

**Stay in touch with FEMA:** When you register, you will be given a FEMA registration number. Write down your number and save it. You will need the number whenever you contact FEMA.
