1.)CALL MEETING TO ORDER.

Mayor Hinojosa called the meeting to order at 6:00 pm.

2.) ESTABLISH QUORUM.

A quorum of the commission was present.

3.) INVOCATION.

Mayor Pro-Tem Gomez led the invocation.

4.) PLEDGE OF ALLEGIANCE.

Commissioner Wade led the pledge of allegiance.

5.) OPEN FORUM-

Joe Perez addressed the Commission regarding the Historical preservation designation areas and his support of a Target store going up in Mercedes. He also had a complaint about his utility bill and the newspapers that public notices are published in.

Jesus Noriega of TxDot gave the Commission an update on the street expansion on Mile 2 West and other projects around the city.

Commissioner Rodriguez recognized Chief Maldonado for all of her work on the Halloween carnival.

7.) REPORT BY DEVELOPMENT CORPORATION EXECUTIVE DIRECTOR. EDC Executive Director Hernan Gonzalez presented his plans for marketing the city and gave an update on the work he has done so far. There was no action taken on this item.

8.) PRESENTATION AND DISCUSSION ON PROPOSED URBAN COUNTY WORK PLAN FOR FISCAL YEAR 27 (2014).

City Manager Ricardo Garcia informed the Commission that one of the recipients of Urban County funds has yet to submit their formal request for funding. If they don't submit a request, that money will be re-allocated to the Library. There was no action taken on this item.

9.) DISCUSSION AND POSSIBLE ACTION OF RESOLUTION #2013-09 CASTING VOTES FOR HIDALGO COUNTY APPRAISAL DISTRICT BOARD.

Commissioner Rodriguez made a motion to approve Resolution #2013-09 Casting votes for David Hernandez for Hidalgo County appraisal District Board. The motion was seconded by Commissioner Guajardo and passed unanimously.

10.) DISCUSSION AND POSSIBLE ACTION REGARDING ADOPTION OF A HISTORICAL PRESERVATION GRANT PROGRAM FOR LOCAL HISTORIC DISTRICTS DESIGNATED THROUGH THE CITY OF MERCEDES.

Assistant City Manager Michelle Leftwich informed the Commission that the Historical preservation Commission has developed a policy for an incentive program for a historic district. The plan will allow homeowners in the Historic district to apply for grants to help pay for roofing and façade repairs. Commissioner Rodriguez made a motion to approve the policy as presented and allow homeowners to apply for up to three grants in a year. The motion was seconded by Mayor Hinojosa and passed unanimously.

11.) DISCUSSION AND POSSIBLE ACTION TO ADOPT A SOCIAL MEDIA POLICY. Several City Boards and departments are starting to maintain an online presence and this social media policy will help give some guidelines for online behavior on behalf of the city. Commissioner Rodriguez made a motion to adopt a social media policy. The motion was seconded by Commissioner Guajardo and passed unanimously.

12.) DISCUSSION AND POSSIBLE ACTION ON HIDALGO STREET BETWEEN OHIO STREET AND ILLINOIS STREET.

Mayor Pro-Tem Gomez made a motion to rescind the resolution that closed Hidalgo Street between Ohio and Illinois Streets. The motion died for lack of a second. There was no further action taken on this item.
