Before calling the meeting to order, Mayor Hinojosa signed a proclamation in support of the Region One ESC My Brother's Keeper- Building Ladders of Opportunity Initiative.

1.) CALL MEETING TO ORDER.

Mayor Hinojosa called the meeting to order at 6:00 PM.

2.) ESTABLISH QUORUM.

A Quorum of the Commission was present.

3.) INVOCATION.

Commissioner Lopez gave the invocation.

4.) PLEDGE OF ALLEGIANCE.

Commissioner Guajardo led the pledge of allegiance.

5.) OPEN FORUM.

Joe Martinez of the Keep Mercedes Beautiful Committee invited the Mayor and Commissioners to participate in a clean-up taking place July 19th.

Commissioner Guajardo made a motion to deviate from the agenda and go to item #8. The motion was seconded by Mayor Pro-Tem Wade and passed unanimously.

8.) DISCUSSION AND POSSIBLE ACTION OF FIRST READING OF ORDINANCE NO. 2014-11 REGARDING TEXAS GAS SERVICE COST OF SERVICE ADJUSTMENT.

Ken Jones of the Lower Rio Grande Valley Development Council addressed the Commission and explained that several Valley cities had joined together to negotiate an agreement with Texas Gas Service regarding the cost of service. As a result of this agreement residential customers will see an estimated 31% decrease in their bills. Commissioner Guajardo made a motion to approve the first reading of Ordinance No. 2014-11 regarding Texas Gas Service cost of service adjustment. The motion was seconded by Commissioner Lopez and passed unanimously.

Commissioner Guajardo made a motion to return to item #6. The motion was seconded by Commissioner Lopez and passed unanimously.

Commissioner Lopez noted that item #2 stated that all members of the commission were present at the meeting held July 1, 2014 when Commissioner Guajardo was actually absent from that meeting. Commissioner Guajardo made a motion to approve all items under consent agenda with the correction being made to the minutes for the meeting held July 1, 2014. The motion was seconded by Commissioner Lopez and passed unanimously.
