Mayor Hinojosa opened the public hearing at 6:16 p.m. Library Director Marisol Vidales addressed the Commission and explained that the proposed historic district includes businesses located along Texas Ave. and several other properties already given a Historic Designation by the State of Texas. The historic designation will allow the property owners to apply for grant funding for repairs to the roof, façade, and leveling of the building. Grant funds will come from the hotel/motel tax fund.

Jodie Martinez, Chairman of the Mercedes Historic Commission also spoke in favor of the historic districts and asked that the Commission consider including properties that had previously been left out at the request of the home owners.

Development Corporation Executive Director Hernan Gonzalez gave an update the cleanup of the H&H property, and several new businesses opening soon including Dona Tota restaurant, The Grind Gym and My Home Furniture Store. Mr. Gonzalez also said that the EDC application for a loan through the Texas Leverage Fund should be approved by December 30, 2014.

This addendum would allow for the City to charge a fee to commercial accounts for brush pickup. Waste Connections has been picking up Commercial brush free of charge since October 1, 2014. Commissioner Guajardo made a motion to approve an addendum to the contract with Waste Connections adding commercial brush and franchise fees (2014-1118B). The motion was seconded by Mayor Pro-Tem Wade and passed unanimously.
