1.) CALL MEETING TO ORDER.

Mayor Hinojosa called the meeting to order at 6:00 p.m.

2.) ESTABLISH QUORUM.

All members of the Commission except Commissioner Gomez were present which constituted a quorum.

3.) INVOCATION.

Commissioner Lopez led the invocation.

4.) PLEDGE OF ALLEGIANCE.

Commissioner Gomez led in the pledge of allegiance.

7.) PRESENTATION OF EDC MONTHLY REPORT.

Mr. Hernan Gonzales proceeded to give the EDC monthly report. He mentioned that they were recognized at the TEDC conference in Galveston as well as by the Hidalgo County commissioners court.

8.) DISCUSSION AND POSSIBLE ACTION ON ADOPTION OF RULES AND PROCEDURES FOR **OPEN FORUM.**

Mr. Garcia presented a draft that the City Attorney and he had worked on for rules and procedures for open forum after taking comments from the City Commission. Thirty minutes are still allowed under open forum with the time being limited to three minutes per spokesperson. In addition, decorum rules were also added, Commissioner Gomez stated that he had wanted no change from the previous rules. Mr. Molina commented that the rules were mostly rules of civility and decorum. Mayor Pro-Tem Guajardo made a motion to approve the rules and procedures for open forum. Commissioner Lopez seconded the motion, which passed unanimously.

9.) DISCUSSION AND POSSIBLE ACTION ON ENTERING INTO CONTRACT WITH REDFISH **RECYCLING.**

Assistant City Manager, Jaime Sandoval informed the Commission that the City's recycling process is becoming more difficult; only Weslaco and Pharr will take the materials which have to be washed and classified. There is a company called Redfish Recycling that will provide the containers and take the material at no cost to the City. The current containers will still be utilized within the community. At a concern by Commissioner Wade regarding people coming in to throw trash, Mr. Sandoval said that the new containers would be placed at city hall. Mayor Pro-Tem Guajardo made a motion to approve entering into contract with Redfish Recycling. Commissioner Lopez seconded the motion, which passed unanimously.

10.) DISCUSSION AND POSSIBLE ACTION OF ORDINANCE NO. 2015-07 AMENDING THE PARKING LOT ORDINANCE 2012-01.

Mr. Sandoval presented an ordinance amending Exhibit C of parking lot ordinance No. 2012-01. He said that the proposed ordinance addresses the downtown area where there is limited or no parking and they cannot comply with the current requirements.

Mayor Pro-Tem Guajardo made a motion to approve the first reading of Ordinance No. 2015-07 amending the parking lot ordinance No. 2012-01. Commissioner Wade seconded the motion, which passed unanimously.

11.) DISCUSSION AND POSSIBLE ACTION APPOINTING AN ALTERNATE TO THE HIDALGO COUNTY METROPOLITAN PLANNING ORGANIZATION

Mr. Garcia stated that the Mayor Pro-Tem normally serves as the alternate to the Mayor on the Hidalgo County MPO. Mayor Pro-Tem Guajardo stated that he could not take on additional duties and proceeded to appoint Commissioner Lopez. Commissioner Lopez commented that he currently serves on Amigos del Valle, therefore, Mayor Pro-Tem Guajardo rescinded his motion and made a motion to appoint Commissioner Wade as alternate to the Hidalgo County Metropolitan Planning Organization. Commissioner Lopez seconded the motion, which passed unanimously.

12.) DISCUSSION AND POSSIBLE ACTION APPOINTING AN ALTERNATE TO THE LRGVDC **BÓARD OF DIRECTORS.**

Commissioner Lopez made a motion to appoint Commissioner Wade as alternate to the LRGVDC Board of Directors. Mayor Pro-Tem Guajarado seconded the motion, which passed unanimously.

The department monthly reports were provided to the Commission.
