1.) CALL MEETING TO ORDER.

Mayor Hinojosa called the meeting to order at 6:00 p.m.

2.) ESTABLISH QUORUM.

A quorum of the commission was present. Mayor Pro-Tem Guajardo entered the meeting during item #7.

3.) INVOCATION.

Rev. Jaquez led the invocation.

4.) PLEDGE OF ALLEGIANCE.

Commissioner Lopez led the pledge of allegiance.

City Manager Ricardo Garcia recognized several police department employees for their work on a case involving a bank robbery.

5.) OPEN FORUM

Petra Vidales spoke about the inspections of the New Football stadium. Leonel Benavides spoke about the budget for fiscal year 2014-2015. Ramon Mejia made a comment regarding a case that the police department is investigating.

6.) CONSENT AGENDA (ORDINANCE NO. 98-21):

She also asked the Commission to decrease spending. Leonel Benavides asked why more money was not being given to the public works department. Velda Garcia asked for street lights to be placed in her neighborhood. Mayor Hinojosa closed the public hearing at 6:34 p.m. There was no action taken on this item.

Hernan Gonzalez made a presentation regarding several projects that the EDC has worked on in the past year. There was no action --taken on this item.
