1.) CALL MEETING TO ORDER.

Mayor Hinojosa called the meeting to order at 6:00 p.m.

2.) ESTABLISH QUORUM.

A quorum of the commission was present.

3.) INVOCATION.

Commissioner Lopez led the invocation.

4.) PLEDGE OF ALLEGIANCE.

Commissioner Wade led the pledge of allegiance.

5.) OPEN FORUM

Petra Vidales spoke about the demolition of the H&H property and the location of the new dome shelter. Hernan Gonzalez, Executive Director of the Mercedes EDC spoke about a publication featuring Mercedes. Armando Garcia gave the Commission some information about the dental and vision insurance available to City employees. Esmer Guerrero spoke about the city spending too much on salaries for employees and grant writers and encouraged the commission to hire more Mercedes citizens. Leonel Benavides spoke about the city's electric bills and the bidding process for professional services.

6.) Consent Agenda (Ordinance No. 98-21):

A.) Approval of Minutes for City Commission meeting (s) held December 15, 2015.

Commissioner Lopez noted a correction to item 7 of the minutes. Mayor Pro-Tem Guajardo made a motion to approve the minutes for City Commission meeting(s) held December 15, 2015 with the correction to item 7. The motion was seconded by Commissioner Lopez and passed unanimously.

7.) Public Hearing to rezone property located at 2402 East West Blvd., described as Lot 2216, being a 2.11 acre tract of land, more or less out of Lot 131, South Campacuas Subdivision, Mercedes, Hidalgo County, Texas from "RMH "to "A-Business" for wine and beer license for Hynes Event Center. The applicant making the request is Llano Grande Lake Park Resort.

Mayor Hinojosa opened the public hearing at 6:13 p.m. Assistant City Manager Jaime Sandoval explained that the rezoning would only affect the new Hynes Event Center located in Llano Grande Lake Park Resort. The change will allow for the sale of alcohol during events as required by TABC regulations. There were no comments from the public and the public hearing was closed at 6:19 p.m.

Mayor Hinojosa, Mayor Pro-Tem Guajardo, Commissioner Wade and Commissioner Lopez in favor and Commissioner Gomez against.

10.) Discussion and possible action on appointment or reappointment of members to the Mercedes Industrial Foundation.

Mayor Hinojosa made a motion to reappoint Heriberto Martinez, Jose I. Flores, Pete Guajardo and Alfredo Hinojosa, Jr. to serve two year terms. The motion was seconded by Mayor Pro-Tem Guajardo and passed unanimously.
