# 1.) CALL MEETING TO ORDER.

Mayor Hinojosa called the meeting to order at 6:00 p.m.

# 2.) ESTABLISH QUORUM.

A quorum of the commission was present.

#### 3.) INVOCATION.

Juan de los Santos led the invocation.

#### 4.) PLEDGE OF ALLEGIANCE.

Commissioner Lopez led the pledge of allegiance.

#### 5.) OPEN FORUM.

Petra Vidales spoke about a State of the City pamphlet sent out with water bills and several construction projects going on in the city.

Esmer Guerrero spoke about the State of The City pamphlets sent out with water bills. Leonel Benavidez spoke about city spending on projects.

## 6.) CONSENT AGENDA (ORDINANCE NO. 98-21):

A.) APPROVAL OF MINUTES FOR CITY COMMISSION MEETING (S) HELD APRIL 19, 2016. B.) SECOND AND FINAL READING OF ORDINANCE NO. 2016-05 -BUDGET AMENDMENTS FOR FISCAL YEAR 2015-2016. C.) REQUEST BY LA MERCED HOMES FOR USE OF CIVIC CENTER FROM JULY 11 TO AUGUST 19, 2016 FOR SUMMER FOOD PROGRAM.

## 7.) PUBLIC HEARING REGARDING A RE-ZONING FROM "A-SINGLE FAMILY RESIDENCE" TO A "B BUSINESS" FOR A DRIVE THRU STORE. THE PROPERTY IS LOCATED AT 10826 MILE 2 WEST, MORE PARTICULARLY DESCRIBED AS THE CAMPACUAS, N. L 10'-S330'-W990' LOT 4 BLK 102 2.50 AC GR 2.42 AC NET, MERCEDES HIDALGO COUNTY, TEXAS. THE PERSON MAKING THE **REQUEST IS CYNDI MARTINEZ.**

Diana Reyes lives across the street from the property in question and spoke against the rezoning. The motion was seconded by Commissioner Lopez and passed unanimously.

City Manager Ricardo Garcia explained that the Memorandum of Understanding would allow the American Red Cross to man the Safe Dome shelter in during an emergency.
