1.) CALL MEETING TO ORDER.

Mayor Hinojosa called the meeting to order at 6:00 p.m.

2.) ESTABLISH QUORUM.

A quorum of the commission was present.

3.) INVOCATION.

Reverend Jacques led the invocation.

4.) PLEDGE OF ALLEGIANCE.

Commissioner Gomez led the pledge of allegiance.

Mayor Hinojosa made a motion to move to item 7 and return to consent agenda after item 8. The motion was seconded by Commissioner Wade and passed unanimously.

7.) Canvass of 2016 City Officer's election for Commissioner Place 2 and Commissioner Place 4.

Mayor Hinojosa read the results of the election held May 7, 2016. They are as follows:

A total of 1,350 votes were cast as follows: 312 votes were cast on Election Day; 875 votes were cast during early voting; 163 absentee ballots were cast and no provisional votes were cast.

Mayor Hinojosa declared James Howard Wade, Jr. was the top vote getter for Commissioner Place 2; therefore he is the winner for that place. Ruben "Chano" Guajardo was the top vote getter for Commissioner Place 4.

8.) Administer Oath of Office to newly elected Commissioner Place 2 and Commissioner Place 4.

Secretary of State Carlos Cascos administered the oath of office for Commissioner Place 2 James Howard Wade, Jr. Commissioner Wade thanked the community for their votes.

Mayor Hinojosa announced that the meeting would break for a small reception. Mayor Hinojosa called the meeting back to order at 6:25 p.m.

Esmer Guerrero spoke about rules being broken be people at the Civic Center during early voting.

Jeff Riviera spoke about the capital improvements done around the city in the last few years and the new businesses coming into Mercedes.

Juanita Rangel spoke in support of the decisions being made by the City Commission and the work being done by city staff.

6.) Consent Agenda (Ordinance No. 98-21):

Mayor Hinojosa made a motion to approve all items under consent agenda with one change to the list of utility account write-offs for 2010-2011. The accounts for the former H&H factory will remain on the list due to a bankruptcy. The motion was seconded by Commissioner Wade and passed unanimously.

- Mayor Hinojosa made a motion to appoint Commissioner Lopez as Mayor Pro-Tem. The motion was seconded by Commissioner Guajardo and passed unanimously.
- 10.) Presentation of Development Corporation of Mercedes, Inc. monthly report. (H. Gonzales). EDC Executive Director presented the Development Corporation of Mercedes, Inc. monthly report. There was no action taken on this item.
- 11.) Discussion and Possible Action of Preliminary and Final Plat for Orchard Grove Villas Subdivision, being 6.00 Acre Tract of Land out of Lot 5, Block 42, Capisallo District Subdivision, Mercedes, Hidalgo County.

Mayor Hinojosa made a motion to approve the preliminary and final plat for Orchard Grove Subdivision, being 6.00 acre tract of land out of Lot 5, Block 42, Capisallo District Subdivision, Mercedes, Hidalgo County. The motion was seconded by Mayor Pro-Tem Lopez and passed unanimously.

12.) Public Hearing and Formal Action regarding a re-zoning from "B Two Family Residence" to "B Business" for a commercial development. The property is located at 1098 W. Expressway 83, more particularly described as 4.376 AC out of Block 67, Mercedes Original Townsite, Mercedes, Hidalgo County, Texas. The entity making the request is Texas Valley Community Foundation.

Mayor Hinojosa opened the public hearing at 6:53 p.m. Steve Gano, the developer of the project proposed for the site. Ramon Mejia asked to know what type of business would be going up on the property. Mayor Hinojosa Closed the public hearing at 6:56 p.m.

Mayor Hinojosa made a motion to approve the first reading of Ordinance No. 2016-06 rezoning property located at 1098 W. Expressway 83, more particularly described as 4.376 Ac. Out of Block 67, Mercedes Original Townsite, Mercedes, Hidalgo County, Texas from "B Two Family Residence" to "B Business" for a commercial development. The motion was seconded by Commissioner Guajardo and passed unanimously.
- 13.) Public Hearing and Formal Action regarding a re-zoning from "B Two Family Residence" to "B Business" for a Mechanical/ Body Shop. The property is located at 110 N. Missouri Ave., more particularly described as Lot 14-16, Block 48, Mercedes Original Townsite, Mercedes, Hidalgo County, Texas. The person making the request is Elias and Dalia A. Gonzalez.

Mayor Hinojosa opened the public hearing at 6:58 p.m. Assistant City Manager Jaime Sandoval explained that the request was denied by the Planning and Zoning Committee at their last meeting due to the City's land use map. The area in question is listed as "Medium Density Residential" and does not support a business going into the area. Elias Gonzalez addressed the Commission regarding his request for the rezone. Mayor Hinojosa closed the public hearing at 7:04 p.m.

- First reading of Ordinance No. 2016-07 re-zoning property located at 110 N. Missouri Ave., more particularly described as Lot 14-16, Block 48, Mercedes Original Townsite, Mercedes, Hidalgo County, Texas from "B Two Family Residence" to "B Business" for a Mechanical/ Body Shop.

Commissioner Guajardo made a motion to table the item for further evaluation by staff. The motion was seconded by Commissioner Wade and passed unanimously with Mayor Pro-Tem Lopez abstaining.

14.) Discussion and possible action regarding an amendment to Ordinance No 2012-12.

The current Ordinance requires that vehicle storage facilities be located within two miles of the city limits. The proposed amendment would increase that requirement to three miles. Commissioner Wade made a motion to approve amendments to Ordinance No. 2012-12. The motion was seconded by Mayor Pro-Tem Lopez and passed unanimously.
