Missouri Ave., 208 S. Illinois, and 322 S. Vermont Ave. Esmer Guerrero asked what the economic impact of the Historic Overlay zone would have on the City. Ms. Vidales explained that the historic properties would attract tourists to the City. Mayor Hinojosa closed the public hearing at 6:13 p.m.

Missouri Ave, more particularly described as Mercedes Original Townsite, Lots 5 & 6, Blk 16;817 Iowa st., more particularly describes as east Mercedes lot 5 blk 2; 208 s. Illinois, more particularly described as Mercedes original Townsite lot 5-8 blk 34; 322 s. Vermont ave., more particularly describes as Mercedes original Townsite lots 16-17-18-19-20-21-22-23 blk 105, Mercedes, Hidalgo County, Texas. The motion was seconded by Mayor Hinojosa and passed unanimously.
