Mailed proposals not received by the deadline will not be opened regardless of the timestamp. Sealed proposals must be identified as "RFQ- Administrative Support Services" on the exterior of the envelope.

Project Description

The City wishes to engage into a contract labor agreement with qualified firms/individuals under a part-time basis (20 hours per week). The selected firm/individual will not be a city employee and will not be eligible for any city benefits (retirement, health insurance etc.) The selected firm/individual will be responsible for all applicable Federal, State and local taxes

Interested Parties should submit a resume detailing applicable work history and experience. At least 3 professional references are required. At minimum, the City is looking for qualifications in the following areas:

- At least 2 years experience in City or County Government in an administrative capacity;
- At least 5 years experience in Federal and State Grant Management;
- At least 5 years experience in oversight and development of municipal infrastructure projects, especially as it relates to TXDoT processes;
- At least 2 years experience in governmental planning and policy development.
