## 7) DISCUSSION AND POSSIBLE ACTION TO APPROVE ACCEPTANCE OF OPIE FUND GRANT FOR USE TOWARD SAVANNAH SOFTWARE FOR THE DR. HECTOR P. GARCIA MEMORIAL LIBRARY
