#### 1. CALL MEETING TO ORDER

Mayor Montoya welcomed everyone and called the meeting to order at 6:30 P.M.

#### 2. ESTABLISH QUORUM

All members of the Commission were present which constitutes a full quorum.

#### 3. INVOCATION

Commissioner Saldana said the invocation.

#### 4. PLEDGE OF ALLEGIANCE

Commissioner Garcia led in the Pledge of Allegiance.

#### 5. OPEN FORUM

- Mr. Fred Money stated the Public Works Department deserve a raise.
- Mr. Ramon Mejia shared a verse from the bible. He added the cost of living is rising and everyone deserves to get raise. Mr. Mejia started addressing the City Manager, Mayor Montoya tried to explain that he cannot direct his comments to an employee. Mr. Mejia continued to speak over the Mayor.
- Mr. Jacob Howell spoke about drainage improvements, sandbags and thanked the employees for their hard work. Mr. Howell thanked several employees in public works. He would like bike patrol in the police department and include a patch in remembrance of David Gobellan who passed away.
- Mr. Adrian Sauceda expressed his concern with Capisallo Terrace not having sanitary sewer. He stated the subdivision gets flooded and with septic tanks it makes it unsanitary. Mr. Sauceda stated that the laborers are out in the heat for \$10 per hour. He stated he will not be silenced.
- Mr. Joaquin Hernandez expressed his concern with the Commission. He stated the employees came to express their concern with their pay at the previous budget meeting. He stated there is an abuse of authority and cannot stop the employees from speaking at meetings.

- Mr. Jaime Contreras asked about the difference between Mr. Mejia and Mr. Howell if they both spoke about employees. Mayor Montoya explained to not bash or disparage an employee. He stated that an increased was promised to the employees and it was approved on the agenda. He added that the employees make \$10 per hour and work in the weather conditions.

#### **6. PRESENTATION:**

a. 2<sup>nd</sup> Presentation and Discussion regarding the proposed budget for FY 2022-2023.

Ms. Meredith Hernandez addressed the Commission about the changes to the budget. She stated that they made the changes as stated at the previous meeting by the Commission regarding sidewalks. They included a line item and allocated \$150K for sidewalks. There was a \$250K increase for the Capisallo Terrace Project. Mr. Perez explained that there are funds coming in for the Capisallo Terrace Project. At a question, Ms. Hernandez stated the increases were budgeted and were at the requests from the department heads.

Ms. Hernandez stated the budget went from \$12.2Million in FY 21-22 to \$14.5 Million in FY 22-23 and added that the budget is balanced. The lowest paid department is public works. Mr. Perez stated the employees receiving an increase will not receive a one time pay in December.

Mayor Pro-Tem Martinez motioned to go into executive session. Commissioner Garcia seconded. The commission went into executive session at 7:14 p.m.

Mayor Montoya called the meeting back to order at 8:03 p.m.

#### 1. CALL MEETING TO ORDER

Mayor Montoya welcomed everyone and called the meeting to order at 6:30 P.M.

#### 2. ESTABLISH QUORUM

All members of the Commission were present which constitutes a full quorum. Mayor Pro-Tem Martinez arrived during open forum.

#### 3. INVOCATION

Commissioner Saldana said the invocation.

#### 4. PLEDGE OF ALLEGIANCE

Commissioner Howell led in the Pledge of Allegiance.

#### 5. OPEN FORUM

- Ms. Jessica Pena expressed her concern with the city. She suffered a substantial loss. An inspection was done before a permit was issued. What training did the person have? Many questions were asked regarding the permit process. During construction the city did not do a drive by to ensure the work was performed. What will be done to make sure the issue does not happen again. She stated that Bison was not to do work in the City. They were following state protocols. The school did not have any roof issues and then stated they did not require an emergency shut down. She stated that the City said the building was condemned. She stated that no one from planning contacted her to inform her what can be done to secure the building to avoid further collapse. The City failed the historical building. The engineer report was obtained.
- Mr. Ramon Mejia provided a document to the Commission. Mercedes belongs to the people. Mr. Mejia stated that the minutes voted to approve the Elidafest, city issued a check for 15K and the event was a month in have after. Every expenditure must be put on heads in bed. This event was not to attract people to stay overnight. The second part is to delegate hotel tax money to another entity. There is no contract for this event. The flyer states that the official hotel is located in McAllen, Texas. Why does the City commission not oversee the actions by the City Manager and Assistant City manager? What other matters are they doing illegally. He stated that this was against the law and will hear it from the state.

- Mr. Jose M. Gomez April meeting item 9a the City Manager set some customer service standard. He stated that the City does not answer the phones. Take ownership, if they have taken ownership through absolute power then the do not have to worry about the citizens. He stated he contacted a Commissioner and stated the I&S has increased and asked that the Commission explain how it increased if the tax rate has remained the same. He stated that the budget should be discussed out in the open.
- Ms. Yolanda Molina expressed her concern with a levee and the traffic in the area. Ms. Molina has been a member of the community for 74 years. She stated the respect for the Community is no longer there. She stated if they speak up then they may get arrested. She is worried about the policemen if the city is paying enough. Ms. Molina expressed her concern with sidewalks on hidalgo street. There is only a small sidewalk in the area and no one cares. She stated there are standards in meetings. There is an attire and hats are not appropriate.
- Ms. Velda Garcia expressed her concern with the Police Department. The fence was locked when she had a meeting at the PD. She stated that the calls are not answered at PD and City hall
- Mr. Joaquin Hernandez stated that PD has not been paid for Elida Fest. He asked for a meeting about not paying the officers. City approved funds for manpower of Elidafest. He asked where is the money. He stated that they selected Municipal services and they do not have a master license. Is the Commission ok with doing nothing? If the Commission doesn't have the courage to do what they are supposed to. He stated there was no contract with Elida Fest and they did not pay the police officers. The city is wasting the money and nothing has been done about Capisallo Terrace. He stated they would contact the state and report the city and get the building shut down. Mercedes does not want this management.
- Mr. Jaime Contreras spoke about the budget and expressed his concern on the increases for public works. He stated that a commissioner told his wife that the public works will not be receiving any stipends and does not think that's right. He stated that a certain individual was investigated and terminated. He was terminated for wiring and finding information on a certain individual. He stated the whole commission is elected to serve.
- Mr. Joel Ruiz expressed how happy he is with the growth in Mercedes. The first growth was the outlet and was able to have 4 job opportunities. He stated the growth will give other residents the opportunity for the same excitement he had and the job opportunities. He stated that visitors and residents will have a broader range of options. He looks forward to more growth in Mercedes.

Mayor Pro-Tem Martinez motioned to approve all items. Commissioner Saldana seconded. Upon a called vote, the motion passed unanimously.

#### 7. CITY MANAGER COMMENTS

#### a. Update on the Status of the A/C units

Mr. Ramirez stated some A/C Units were replaced in the Library and the City Hall. There is another unit they are looking to repair but does not have an end time. The dome A/C is being repaired by Texas Air System. There were estimates previously provided costing the city over \$150K and now the cost is \$18K. The company is a sole source and the AC units currently do not have warranty. The \$150 was for new units and the engineer reviewed it and recommended repairs. Mr. Perez stated that workmanship is usually warranted for one year.

#### 8. ORDINANCES/RESOLUTIONS

a. Ordinance 2022-21 to Rezone Mercedes Original Townsite lot 14 Blk 123 from Class "B" Two Family Residence to Class "C-1" Apartment District Applicant Israel Formacio

Commissioner Howell made a motion to approve. Commissioner Saldana seconded. Commissioner Howell stated it would increase revenue. Upon a called vote, the motion passed unanimously.

b. Ordinance 2022-22 to Rezone Lot 132, Block 112, South Campacuas Addition Tract 1 (7.374 Acres), Part of a Called 28.56 Acres from Class "N" Newly Annexed to Class "L1" Light Industrial Applicant John M. Harrison

Commissioner Saldana motioned to approve. Mayor Pro-Tem Martinez seconded. Commissioner Howell asked the location. Commissioner Saldana stated this is on Mile 2 W. Upon a called vote, the motion passed unanimously.

c. Ordinance 2022-23 to Rezone Grousshouser's Subdivision 222.05 Feet West of Lot 5 and 6 from Class "C" Apartment District to Class "B" Business. Applicant Tiki Land Company

Commissioner Howell motioned to approve. Mayor Pro-Tem Martinez seconded. Commissioner Howell stated this is an opportunity for the city to grow and increase revenues. Mr. Ramirez stated that this is on FM491 and Mile 8.

#### 9. MANAGEMENT ITEMS:

a. Researching for a K-9 Unit and Bike Patrol for the Police Department.

Commissioner Howell and Commissioner Garcia placed this item on the agenda. Commissioner Howell would like to see a bike patrol for PD and a K-9 unit. He wants the city to provide resources for the police officers. Commissioner Howell would like three officers and a dog and get training for the officers. Safety is a priority for Commissioner Howell. Commissioner Howell stated there are grants to fund these positions. Commissioner Howell motioned to move forward with researching the costs. Mayor Pro-Tem Martinez seconded. Mayor Pro-Tem Martinez stated the training, costs and the requirements to have a K-9 Unit. The dog is also an officer. Commissioner Howell stated that the city will not need to rely on other cities to provide the K-9 unit. Upon a called vote, the motion passed unanimously.

#### 10. BIDS/CONTRACTS

a. FY 2022-2023 Interlocal Agreement between the City of Mercedes and the County of Hidalgo Urban County Program

Mr. Ramirez stated this interlocal is for the urban county program and is done every year. Commissioner Saldana motioned to approve. Commissioner Garcia seconded. Commissioner Saldana stated the county received \$7.5 Mil and the City of Mercedes only received \$257K. Mayor Montoya stated that the money belongs to the Precinct and they decide how much goes to each city. Commissioner Saldana stated his appreciation to the detail in the urban county agreement and funds. Mr. Perez stated the funding is going to streets lights and parks. Upon a called vote, the motion passed unanimously.

b. Approval of Interlocal Agreement between the County of Hidalgo and the City of Mercedes for the Dawson Rd. Improvements.

Commissioner Saldana motioned to approve. Commissioner Garcia seconded. Upon a called vote, the motion passed unanimously. Commissioner Saldana asked for the potential start date for the project. Mr. Perez stated they are ready to start but are waiting for the urban county funds which is now approved. Mr. Ramirez stated they should start in the next two weeks. Upon a called vote, the motion passed unanimously.

#### 11. MONTHLY DEPARTMENTAL REPORTS

Included in the packet was the August monthly report for PD, PW, Library, Rec Center, Finance, Planning, City Secretary/HR/PIO, & Fire. Commissioner Saldana asked about Page 119 (Public Works report) the "22" for the Citizen collection station. Mr. Ramirez stated that the Citizen

collection station is open on Friday and Saturday. On page 149 regarding the finance, Commissioner Saldana stated he would like a status report on the audit findings and what was addressed. Ms. Perez stated that three issues have been corrected and two are still pending. Looking at hiring more staff to assist in programming fixed assets and the TIRZ account. Mr. Perez stated that if they cannot find someone they can outsource the service to get them up to date and then hire. Mr. Perez stated they are still in communication with TIRZ to clear up the issue. Commissioner Howell asked about revenues, are we still in the positive, Ms. Perez stated yes. Ms. Perez stated she will notify the City Manager if the city is not meeting the revenues then the city will need to cut back on expenses. Ms. Longoria stated there are 7 positions open on patrol. Ms. Perez stated that the funds allocated for the positions get used for overtime. Mr. Sanchez stated that the turn over is a problem everyone is facing.

Mayor Pro-Tem Martinez motioned to go into executive. Commissioner Saldana seconded. Upon a called vote, the motion passed unanimously at 7:33 P.M.

AN ORDINANCE CHANGING THE CLASSIFICATION FOR ZONING PURPOSES OF THE FOLLOWING TRACT OF LAND: MERCEDES ORIGINAL TOWNSITE LOT 14 BLK 123, FROM CLASS "B" TWO FAMILY RESIDENCE TO CLASS "C-1" APARTMENT DISTRICT; PROVIDING FOR A SAVINGS AND REPEAL CLAUSE; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on the 12<sup>th</sup> day of September, 2022 a public hearing was held for the purpose of hearing any objections as to why: MERCEDES ORIGINAL TOWNSITE LOT 14 BLK 123, Mercedes, Hidalgo County, Texas, should be rezoned and classified as follows: from a Class "B" Two Family Residence to a Class "C-1" Apartment District.

WHEREAS, the City Commission at its Regular Meeting of September 20<sup>th</sup>, 2022, having considered the rezoning of the above-described property as listed in the foregoing section and having heard the pros and cons as to such rezoning request, is of the opinion that the aforementioned rezoning is in the best interest of the City of Mercedes, Texas.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF MERCEDES, TEXAS:

Section 1 Mercedes Original Townsite Lot 14 Blk 123, Mercedes, Hidalgo County, Texas, should be rezoned and classified as follows: from a Class "B" Two Family Residence to a Class "C-1" Apartment District.

**Section 2:** That the aforementioned rezoning of the above property be incorporated into the official map of the City of Mercedes, Texas by the City Planner of said City.

Section 3: That if any provision, section, subsection, phrase, paragraph, sentence, clause or portion of this Ordinance shall for any reason be declared invalid, such invalidity shall not affect the remaining provisions of this Ordinance or their application of persons or sets of circumstances and to this end, all provisions of this Ordinance or parts of Ordinances in conflict herewith are hereby repealed.

**Section 4:** This Ordinance shall become and be effective in accordance with the City Charter of the City of Mercedes, Texas and the laws of the State of Texas.

AN ORDINANCE CHANGING THE CLASSIFICATION FOR ZONING PURPOSES OF THE FOLLOWING TRACT OF LAND: LOT 132, BLOCK 112, SOUTH CAMPACUAS ADDITION TRACT 1 (7.374 ACRES, PART OF A CALLED 28.56 ACRES, FROM "N" NEWLY ANNEXED TO CLASS "LI" LIGHT INDUSTRIAL; PROVIDING FOR A SAVINGS AND REPEAL CLAUSE; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on the 12<sup>th</sup> day of September, 2022 a public hearing was held for the purpose of hearing any objections as to why: BLOCK 112, SOUTH CAMPACUAS ADDITION TRACT 1 (7.374 ACRES, PART OF A CALLED 28.56 ACRES, Mercedes, Hidalgo County, Texas, should be rezoned and classified as follows: from a Class "N" Newly Annexed to a Class "LI" Light Industrial.



AN ORDINANCE OF THE CITY OF MERCEDES, TEXAS. FINDING AND DETERMINING THAT PUBLIC CONVENIENCE AND NECESSITY NO LONGER REQUIRES THE CONTINUED EXISTENCE OF THE ALLEY ABUTTING THE PROPERTY DESCRIBED AS 0.069 OF ONE-ACRE (3,000 SQ, FT.) OF LAND, BEING A PORTION OF A 20' PUBLIC ALLEY LOCATED BETWEEN MISSOURI AVENUE AND TEXAS AVENUE OF THE ORIGINAL TOWNSITE OF MERCEDES, AS SHOWN ON A MAP RECORDED IN VOLUME U, PAGES 19-20, H.C.D.R; VACATING AND ABANDONING SAID ALLEY, AUTHORIZING THE MAYOR TO **CITY SECRETARY EXECUTE AND** THE TO ATTEST; RESPECTFULLY, CONVEYING THE SAID ABANDONED ALLEY TO THE DEVELOPMENT CORPORATION OF MERCEDES: PROVIDING FOR SEVERABILITY; AND CONTAINING OTHER PROVISIONS RELATING TO THE SUBJECT.

**WHEREAS**, the City Commission of the City of Mercedes, Texas finds that public convenience and necessity no longer require the continued existence of the alley abutting the property described as 0.069 of one-acre (3,000 Sq. Ft.) of Land, being a portion of a 20' Public Alley located between Missouri avenue and Texas Avenue of the Original townsite of Mercedes, as shown on a map recorded in volume u, pages 19-20, H.C.D.R, Mercedes, Hidalgo County, Texas and for the reason that the same is no longer needed by the City, now, therefore;

# BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF MERCEDES, TEXAS:

- **Section 1**. The facts and recitations set forth in the preamble of this Ordinance are hereby found to be true and correct.
- **Section 2**. The city Commission of the City of Mercedes, Texas hereby finds and determines that public convenience and necessity no longer require the continued existence of that portion of alley described below in Section 3 hereof.
- **Section 3**. The alley abutting the property more particularly described as 0.069 of one-acre (3,000 Sq. Ft.) of Land, being a portion of a 20' Public Alley located between Missouri avenue and Texas Avenue of the Original townsite of Mercedes, as shown on a map recorded in volume u, pages 19-20, H.C.D.R, located within the City of Mercedes, Hidalgo County, Texas is hereby vacated and abandoned, Attached hereto as "Exhibit A" and "Exhibit B".
- **Section 4.** The Mayor and City Secretary are hereby authorized to execute and attest, respectively, any documents abandoning the alley abutting the property described in Section 3 and conveying the said abandoned alley to the Development Corporation of Mercedes.
- **Section 5**. In the event any section, paragraph, subdivision, clause, phrase, provision, sentence, or part of this ordinance or the application of the same to any person or circumstance shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction,

shall not affect, impair, or invalidate this ordinance as a whole or in any part of provision hereof other than the part declared to be invalid or unconstitutional; and the City Commission of the City of Mercedes, Texas, declares that it would have passed each and every part of the same notwithstanding the omission of any such part thus declared to be invalid or unconstitutional, or whether there be one or more parts.

**Section 6**. This Ordinance shall become effective upon final reading and adoption of this Ordinance when the caption hereof is caused to be published once in the official newspaper of the City, by the City Secretary, as required by law.


