ORDINANCE NO. 2023-03

AN ORDINANCE OF THE CITY OF MERCEDES, TEXAS (CITY) AMENDING ORDINANCE NO. 2022-08; ADOPTING NEW UTILITY RATES FOR WATER AND SEWER; IMPLEMENTING A 1" METER-SIZE BASED MINIMUM CHARGE STRUCTURE FOR WATER SERVICE FOR SENIOR CITIZENS; INCREASING MINIMUM CHARGES AND VOLUMETRIC RATES EACH YEAR FROM EFFECTIVE DATE THROUGH OCTOBER 2026 AT THE LEVELS INDICATED IN THE RATE TABLES PROVIDED WITHIN THIS ORDINANCE, SAID RATE INCREASES TO AUTOMATICALLY GO INTO EFFECT AND FOR EACH SUBSEQUENT YEAR THEREAFTER THROUGH OCTOBER 2026 UNLESS THE CITY TAKES ACTION TO REVISE THIS ORDINANCE; AUTHORIZING THE MAYOR TO ORDER THE IMPLEMENTATION OF THE AMENDED RATE SCHEDULE WITHIN THE CITY'S SERVICE AREA; DECLARING A PUBLIC PURPOSE; PROVIDING A REPEALER; PROVIDING FOR SEVERABILITY; AND SETTING AN EFFECTIVE DATE

WHEREAS, the City of Mercedes wishes to amend its utility rate schedule as approved and implemented by Ordinance No. 2022-08; and

WHEREAS, the governing body of the City has determined the rates for providing municipal utility services requires adjustment in order to reflect its actual costs and to assure the City's continued financial ability to provide these services; and

WHEREAS, the water and wastewater systems continue to grow at increased levels each year and the expansion, rehabilitation and improvement needs of existing infrastructure is critical; and;

WHEREAS, funding the water and wastewater system's capital expansion and improvement plans will require the issuance of revenue and other bonds, the repayment of which will come primarily from the revenues generated by the respective system's user fees and charges; now

BE IT ORDAINED BY THE CITY COMMISSION OF MERCEDES, TEXAS THAT:

SECTION 1. <u>AMENDING</u> the utility rate schedule attached as Exhibit "A" (Exhibit) in regards to the proposed utility rates for Senior Citizens ICL and Senior Citizens OCL and to implement the 1" meter-size base rate and increase the minimum charges and volumetric rates each year from effective date through October 2026.

SECTION 2. <u>AUTHORIZATION</u> The updated utility rate schedule attached as Exhibit "A" (Exhibit) hereto is adopted and approved by the City Commission. The Mayor is authorized to order the implementation of the amended rate schedule within the City of Mercedes service area as set forth in the Exhibit. Said Exhibit is approved and incorporated herein for all purposes as if fully copied and set forth at length.

SECTION 3. <u>INCORPORATION OF RECITALS</u> The City Commission finds the recitals contained in the preamble to this ordinance are true and correct and incorporates them as findings of fact.

SECTION 4. <u>**REPEALER.**</u> All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 5. <u>SEVERABILITY.</u> If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or illegal, such decision shall not affect the validity of the remaining sections of this Ordinance. The City Commission hereby declares that it would have passed this Ordinance, and each section, subsection, clause, or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases be declared void; and that in lieu of each clause or provision of this Ordinance that is invalid, illegal, or unenforceable there be added by the Mayor as necessary with the approval of the City Attorney as to form, and as a part of the Ordinance a clause or provision as similar in terms to such invalid, illegal or unenforceable clause or provision as may be possible, legal, valid and enforceable.

SECTION 6. <u>EFFECTIVE DATE</u>. The Ordinance shall be effective immediately upon the approval of the City Commission.

(a) *Premises connected with water system*. Charges shall be paid by all persons owning or occupying premises which are connected with the water system in accordance with the following schedule of rates; and such charges as are hereinafter described are hereby levied and assessed, as hereinafter provided:

ORDINANCE NO. 2023-04

AN ORDINANCE AMENDING ORDINANCE 2022-08 TO INCLUDE -TAPPING FEES, INSTALLATION FEES, PAYMENT, DEPOSIT AND FEES FOR LATE PAYMENT OF BILLS, AND WATER RIGHTS FEE; REPEALING ORDINANCE 2022-06 AND 2022-13 AND SUBSEQUENT WATER AND SEWER RATE ORDINANCES AND PROVIDING FOR A SAVINGS AND REPEAL CLAUSE; PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF MERCEDES, TEXAS:

Section – 1: The City of Mercedes has approved and adopted the water and sewer rates on June 21, 2022 as Ordinance 2022-08. The City of Mercedes has found a need to include fees as and amendment to the water and sewer rates ordinance as follows:

SCHEDULE A – WATER & SEWER RATES

Water and Sewer rates as approved by Ordinance 2022-08. This section may be changed in accordance with the water and sewer rate study.

SCHEDULE B – TAPPING FEES

That the following charges shall be made as tapping fees for making connections for the use of any water user:

5/8" x ¾" connection - \$800.00 plus water rights, paving and boring fees

34" connection - \$880.00 plus water rights, paving and boring fees

1" connection - \$945.00 plus water rights, paving and boring fees

 $1 \frac{1}{2^{"}} - 4^{"}$ connection – Actual costs associated with tap, materials, labor and paving repairs and 10% of the actual cost for administrative fees.

That the following charges shall be made as tapping fees for making connections for the use of any sewer user:

4" service line connection - \$600.00 plus paving and boring fees.

6" or greater service line connections – Actual costs associated with tap, materials, labor and paving repairs and 10% of the actual cost for administrative fees.

SCHEDULE C – METER INSTALLATION FEE FOR EXISTING WATER TAPS

5/8" x ¾" connection - \$440.00 ¾" connection - \$520.00 1" connection - \$580.00 1 1/2" – 4" connection – Actual costs associated with meter, materials, and labor.

SCHEDULE D – PAYMENT, PENALTY FOR LATE PAYMENT; TERMINATION OF SERVICES, NSF CHARGE

All bills including water, sewer, refuse, and special assessments, will be due 15 calendar days form the date of issue of such bill. If payment is not received by said due date, a penalty of ten percent (10%) shall be added to the original amount. Should any account remain unpaid for seven (7) days past the due date, the customer shall be considered delinquent and services terminated without further notice. Customers must pay the full amount due for utility and garbage services before service is reconnected. No new utility accounts may be opened for a customer who has an outstanding delinquent account for utility services. Other services, such as building permit sales may be withheld until such time the utility

account is paid in full. A \$35.00 fee will be charged to reinstate an account during normal business hours and a \$50.00 fee will be charged to reinstate an account after hours. After a customer has been disconnected, no one shall make a reconnection or obtain any water by any manner from the disconnected place, except by authorized employees of the Water Department. An NSF charge of Thirty Dollars (\$30.00) will be made to the customer's account for each returned check. If a customer requests a reread of their meter, and the initial reading by the City is correct, there will be a \$35.00 service call fee added to the customer's current monthly bill.

It shall be unlawful for any person or firm not so authorized, to tamper, share, adjust, replace or misuse any water meter owned by the City of Mercedes. Any person in violation of this section shall be fined Five Hundred Dollars (\$500.00) plus any dames as a result of such tampering plus an administrative fee, and estimated rate loss. The City has right to file criminal charges in court.

SCHEDULE E – DEPOSIT

A deposit of \$100.00 for homeowners and \$150 for renters shall be required for service for all new residential accounts. A deposit of \$200.00 shall be required for service for all new commercial accounts. Such deposit fees, exclusive of Interest earned, shall be returned to the customer upon closing of the account and full payment of the final account bill by the customer.

SCHEDULE F – WATER RIGHTS FEE

For all service applications, the City of Mercedes will determine the quantity and fee for MUNICIPAL water rights. The required amount of MUNICIPAL water rights for standard service will be equal to the size of the requested water meter(s) expressed in the number of equivalent 5/8" meter units multiplied by 0.2-acre feet. The number of equivalent 5/8" meter units will be determined using AWWA standards. The amount of MUNICIPAL water rights required for NON-STANDARD service will be determined on an individual basis. The City Manager or City Manager's Designee, will assess a fee based upon the price of pooled MUNICIPAL water rights that are available through the City of Mercedes or the current market price. This fee will also include applicable estimated administrative and legal fees. In lieu of paying the assessed fee for MUNICIPAL water rights, applicant may choose to provide City of Mercedes with the required MUNICIPAL water right.

SCHEDULE G – PAYMENT ARRANGEMENT AND FAILED PAYMENT ARRAINGEMENTS

Payment arrangements must be made through the Utility Billing Department for any utility services. A payment arrangement may be requested at any time during the year; however, if an account has three (3) failed payment arrangements in a twelve (12) month period, no more payment arrangements will be allowed and disconnection will commence.

SECTION 2. Residential users who are 62 years of age or older or residential users who are Veterans of the armed forces of the United States of America may receive a \$5.60 per month reduction in the base charge for the water and sewer for one residence only. A residential user who is both 62 years of age or older and a veteran of the armed forces of the United States of America will qualify for only one reduction in rate, either the 62 years of age or older or the veteran's reduction, but not both. The residential user must apply for the reduction at the water department and must provide proof of his/her status as either over 62 years of age or veteran. The reduction will take effect on the following billing cycle and will not be retroactive. Applicants may be required to reapply annually.

SECTION 3. If any section, subsection, phrase, sentence, clause or provision of this ordinance shall be declared invalid for any reason, such invalidity shall not affect the remaining provisions of this Ordinance or their applications to other persons or sets of circumstances, and to this end, all provisions of this Ordinance are declared to be severable and all ordinances or parts of ordinances regarding water and sewer rates, including Ordinance No. 2022-06 & 2022-13 in conflict herewith are hereby repealed.

SECTION 4. This Ordinance shall become and be effective in accordance with the City Charter of the City of Mercedes, Texas and the laws of the State of Texas.

- ITEM: Discussion and possible action to appoint a member to the Mercedes Historic Preservation Commission.

BACKGROUND INFORMATION:

The Mercedes Historic Preservation Commission is a 7-member and 2-alternate member advisory board for the City of Mercedes. Its purpose is to maximize conservation & preservation of any historical landmarks for future generations to discover, and appreciate Mercedes' structural heritage...

The board's scope of work includes the following:

- •Nominates properties for local historic designation
- Reviews grant applications for local historic properties
- Provides suggestions for work performed on local historic properties
- •Research history on local historic properties
- •Review applications for historical business awards

At this time, we have a total of four vacancies on the board. Three for a regular member as well as the one alternate positions. Ms. Erin Pena who was originally going to serve as our historian was unable to make the meetings due to work causing our fourth vacancy. The one alternate position has been vacant for close to three years.

We have one applicant at this time which is Mr. Gabriel Ozuna.

Our manual states the following:

At least one member shall be an architect, planner, or representative of a design profession;

At least one member shall be a historian;

At least one member shall be a licensed real estate broker;

At least one member shall be an attorney;

At least one shall be an owner of a landmark or of a property in a historic district;

At least one shall be an archeologist or from a related discipline;

Mr. Ozuna would fulfill the requirement of a historian. He has a Bachelor's of Arts in History from Yale University and a Master of Arts in History from UTRGV. He also serves as the Historic Preservation Coordinator for the Mission Historical Museum.

He also recently discovered a grant for façade repairs to historical businesses and encourage and assisted El Fenix café to apply.

If appointed Mr. Ozuna's term would run until October 2024.

We do still need an attorney and planner on our board.

- Prepared and submitted agenda items for the City Commission meeting regarding Friends of the Library, Interlocal Agreement, and LEAP launch.
- Researched and submitted status report of open purchase orders to the Finance Department.
- Finished Magazine project, which allows magazines to be checked out by the public.
- Installed new teen shelving which included having the older shelving removed by Public Works, removing and storing the entire YA fiction collection, working with installer on how the shelving should be set up, and finally, placing all the collection back on the shelves and shifting some of the young adult shelving.
- Worked with Microsoft and City IT to create Microsoft Volume Licensing account in order to have access to the Library's Microsoft licenses. Once obtaining access the new Circulation computer finally had the Microsoft Office suite installed.
- Worked on collection development for cloudLibrary with a concentration on holds, requests, and adult fiction titles. Also reviewed field guide book titles to select a few to enhance our nature backpack program.
- Started working on the city's Livestock Show float by submitting application and requesting quotations for the material needed to build the float.
- Completed and provided two reference requests for previous library employees.
- Completed the Memorandum of Understanding between Friends of the Library and the Library Board.

- Reviewed café sales for the past 2 months to determine what products to keep or remove, updated the café menu, created the café specials, and revised some café menus to establish better consistency of product.
- Removed all previous art work from Gallery 434 and installed a total of 55 quilt pieces for the February exhibition.






