## Local Park Grant Program Resolution Authorizing Application

A resolution of the <u>City of Mercedes</u> as hereinafter referred to as "Applicant," designating certain officials as being responsible for, acting for, and on behalf of the Applicant in dealing with the Texas Parks & Wildlife Department, hereinafter referred to as "Department," for the purpose of participating in the <u>Local</u> <u>Park Grant Program</u>, hereinafter referred to as the "Program"; certifying that the Applicant is eligible to receive program assistance; certifying that the Applicant matching share is readily available; and dedicating the proposed site for permanent (or for the term of the lease for leased property) public park and recreational uses.

WHEREAS, the Applicant is fully eligible to receive assistance under the Program; and

**WHEREAS**, the Applicant is desirous of authorizing an official to represent and act for the Applicant in dealing with the Department concerning the Program;

## BE IT RESOLVED BY THE APPLICANT:

- **SECTION 1:** That the Applicant hereby certifies that they are eligible to receive assistance under the Program, and that notice of the application has been posted according to local public hearing requirements.
- **SECTION 2:** That the Applicant hereby certifies that the matching share for this application is readily available at this time.
- **SECTION 3:** That the Applicant hereby authorizes and directs the <u>City Manager</u> to act for the Applicant in dealing with the Department for the purposes of the Program, and that <u>Alberto Perez</u> is hereby officially designated as the representative in this regard.
- **SECTION 4:** The Applicant hereby specifically authorizes the official to make application to the Department concerning the site to be known as <u>Mercedes Sports Complex</u> in the <u>City</u> of <u>Mercedes</u> or use as a park site and is hereby dedicated (or will be dedicated upon completion of the proposed acquisition) for public park and recreation purposes in perpetuity (or for the lease term, if legal control is through a lease). Projects with federal monies may have differing requirements.

## **RESOLUTION 2024-23**

## A RESOLUTION OF THE CITY OF MERCEDES TO UPDATE THE EXISTING 2019 PARK AND OPEN SPACE MASTER PARK PLAN TO INCLUDE THE CITY OF MERCEDES SPORTS COMPLEX PUBLIC ENGAGEMENT SURVEY RESULTS; AND TO ADD AN OPERATIONS AND MAINTENANCE PLAN.

**WHEREAS**, the City of Mercedes recognizes the importance of maintaining and updating its Park and Open Space Master Park Plan to reflect the evolving needs and preferences of its residents; and

**WHEREAS**, the 2019 Park and Open Space Master Park Plan serves as a crucial guide for the development and management of parks, recreational facilities, and open spaces within the city; and

**WHEREAS**, the City of Mercedes has conducted a public engagement survey to gather input from residents regarding the City of Mercedes Sports Complex; and

**WHEREAS**, the survey results provide valuable insights into the community's desires and expectations for the sports complex and other recreational facilities; and

**WHEREAS**, an updated operations and maintenance plan is essential to ensure the longevity, safety, and usability of the city's parks and recreational facilities;

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF MERCEDES, TEXAS:

**SECTION 1:** The City of Mercedes hereby adopts the public engagement survey results related to the City of Mercedes Sports Complex as an integral part of the 2019 Park and Open Space Master Park Plan.

**SECTION 2:** The City of Mercedes directs the appropriate departments to incorporate the survey results into the existing 2019 Park and Open Space Master Park Plan to ensure that the plan accurately reflects the community's current recreational needs and preferences.

**SECTION 3:** The City of Mercedes authorizes the development and inclusion of a comprehensive operations and maintenance plan for the parks and recreational facilities within the updated Master Park Plan. This plan will outline the necessary procedures, schedules, and resource allocations required to maintain the quality and safety of the city's parks and recreational spaces.

**SECTION 4:** The City Manager or their designee is hereby authorized to take all necessary actions to implement the updates to the 2019 Park and Open Space Master Park Plan as specified in this resolution.

**SECTION 5:** This resolution shall take effect immediately upon its adoption.




What is your gender?




What is your age group?




## Do you reside in the City of Mercedes? 256 responses




How often you and/or anyone in your household visited the Mercedes Sports Complex in the past year.




How likely is it that you would recommend the Mercedes Sports Complex to a friend or colleague? <sup>256</sup> responses






Indicate the activities you will like to participate in when you visit the Mercedes Sports Complex. 256 responses



How important is it for you that Mercedes Sports Complex is well-lighted? 256 responses





How often you and/or anyone in your household visited the Mercedes Sports Complex in the past year.




How likely is it that you would recommend the Mercedes Sports Complex to a friend or colleague? 145 responses


