5. PROJECT UPDATES:

Mr. Ramirez informed the city commission on the ongoing projects in the city on the 10th street and Capisallo Terrace Project. On 10th street project waterline replacement and resurface of street the waterline should be 100% completion by Saturday August 06, 2024 that would be the section on 491 to Florida Street they are working on the tie ends at the moment on the Florida street side and Canal street. The curb and gutter replacement began and that project should be done by the upcoming days. Seems that project is on schedule on repaving 491 to Florida street by August 14, 2024. Capisallo Terrace Sewer Project has been completed for almost a month and will begin paving on Thursday August 01, 2024 this project is with Precinct 1. The water line project plans for 10th Street from Ohio to Maryland will be completed by Friday. Mayor Montoya would like an update on the land acquisition by the railroad and the pooling of water on Business 83 by the pizza hut and dairy queen.

Engineer Israel gave a briefing on the background on the annual Bid for Roofing and went out for proposal RFP 2024-016 Roof replacement repair and related services original date was July 3, 2024 and city only received one respondent so than we extended the date because we received two calls and only one actually received one contractor go out to the site and so we reached out to Betancourt Legacy Construction. They do have experience in built up roofs. We are selecting the contractor and if approved they will then go and visit with the contractor to price it out. Mr. Posadas recommended proceeding with Betancourt. Commissioner Garcia motioned to approve. Commissioner Howell seconded. Upon a called vote, the motion passed unanimously.
